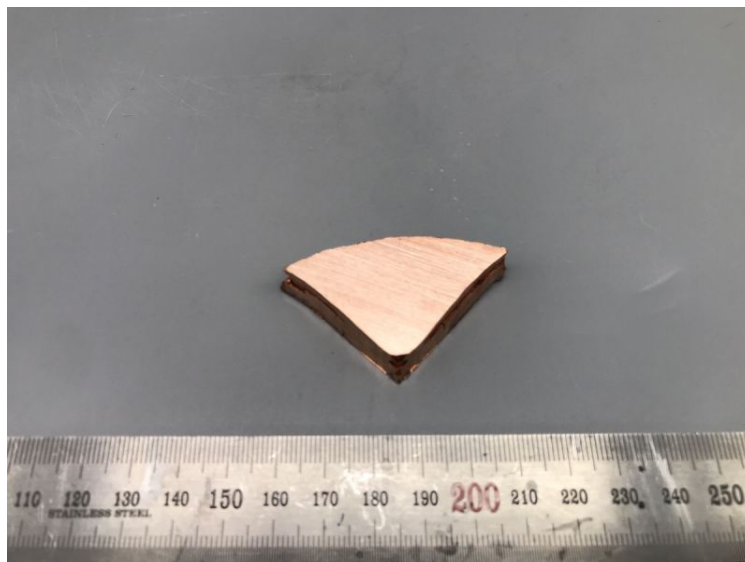

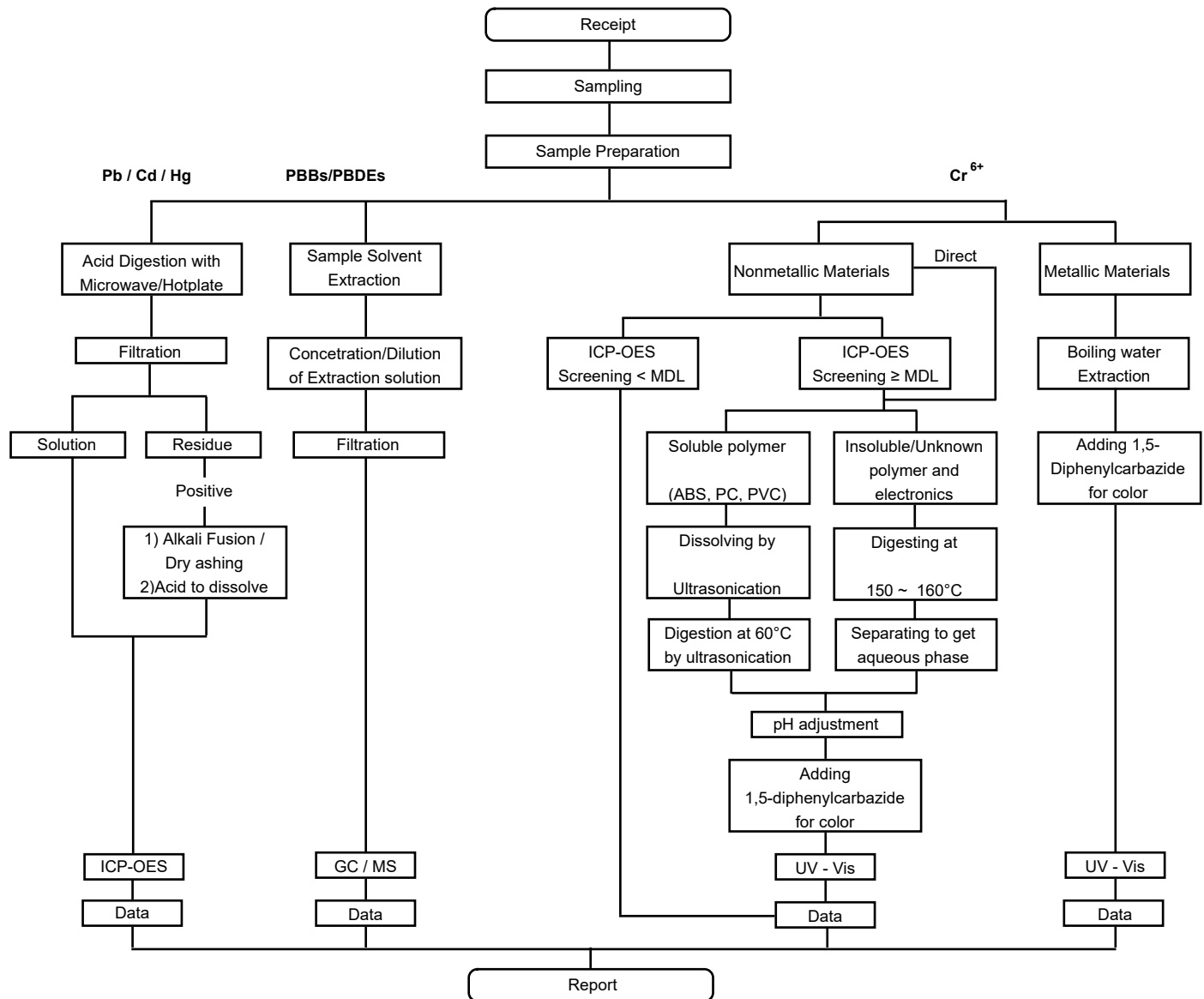

Picture of Sample as Received:

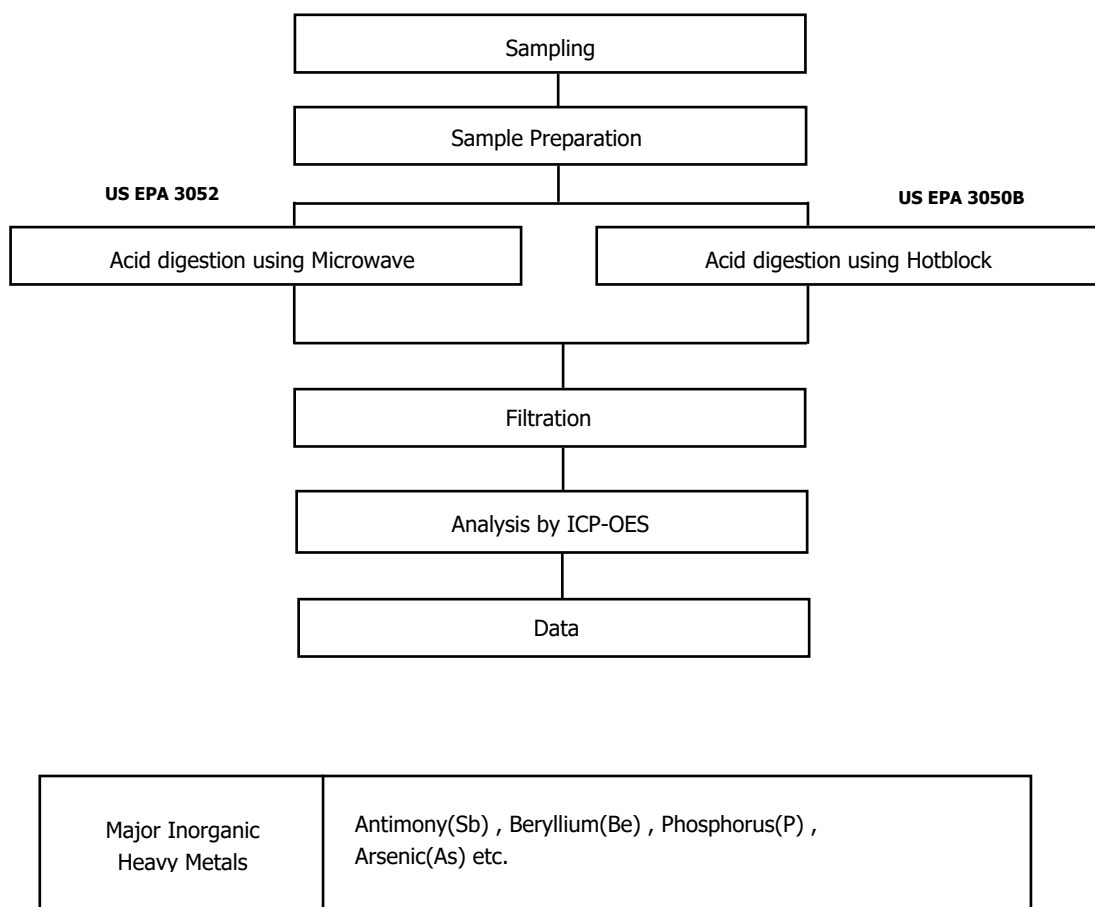

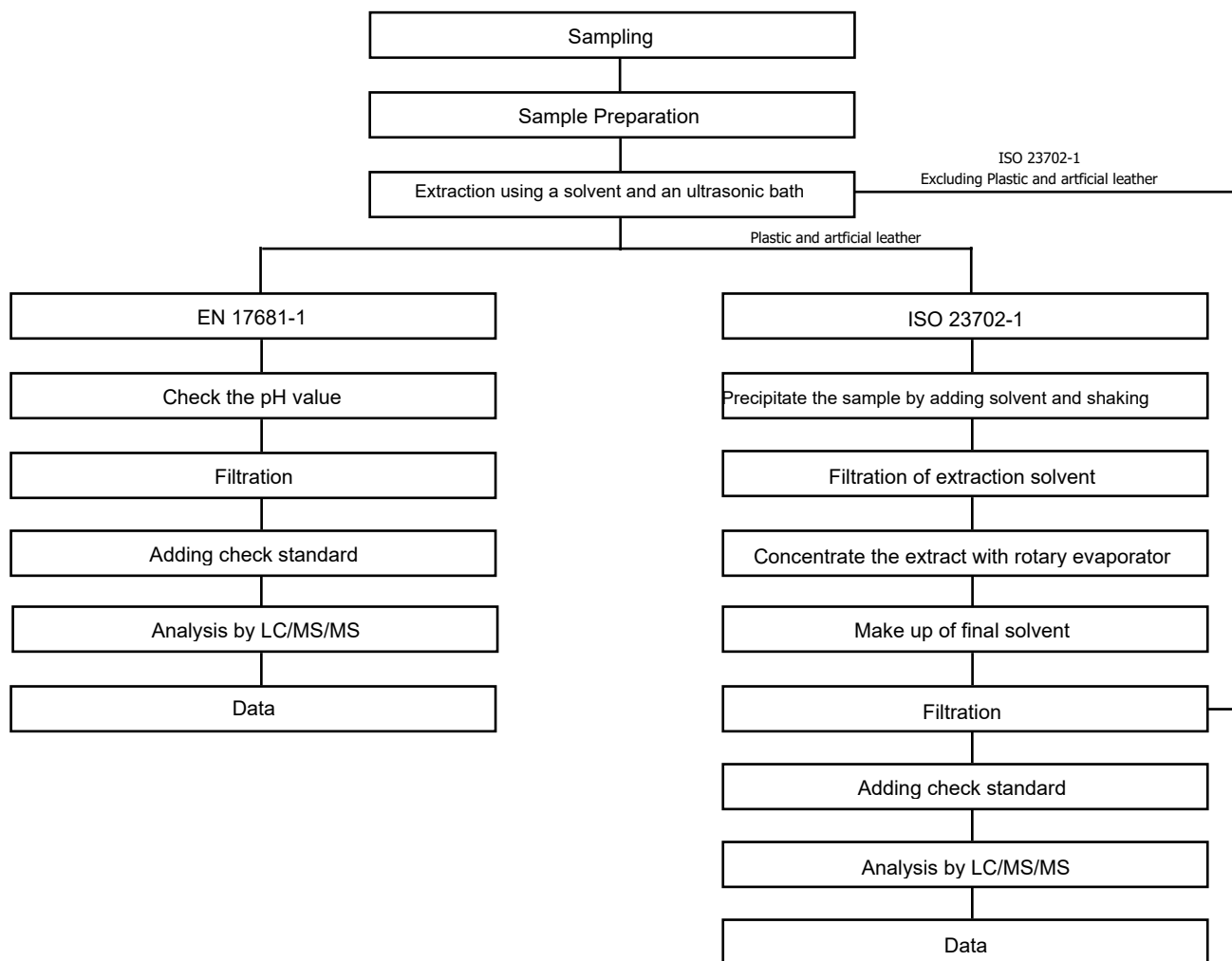
Flow Chart for RoHS Pb / Cd / Hg / Cr⁶⁺ / PBBs&PBDEs Test


The samples were dissolved totally at the acid digestion step of the above flow chart for Cd, Pb, Hg.

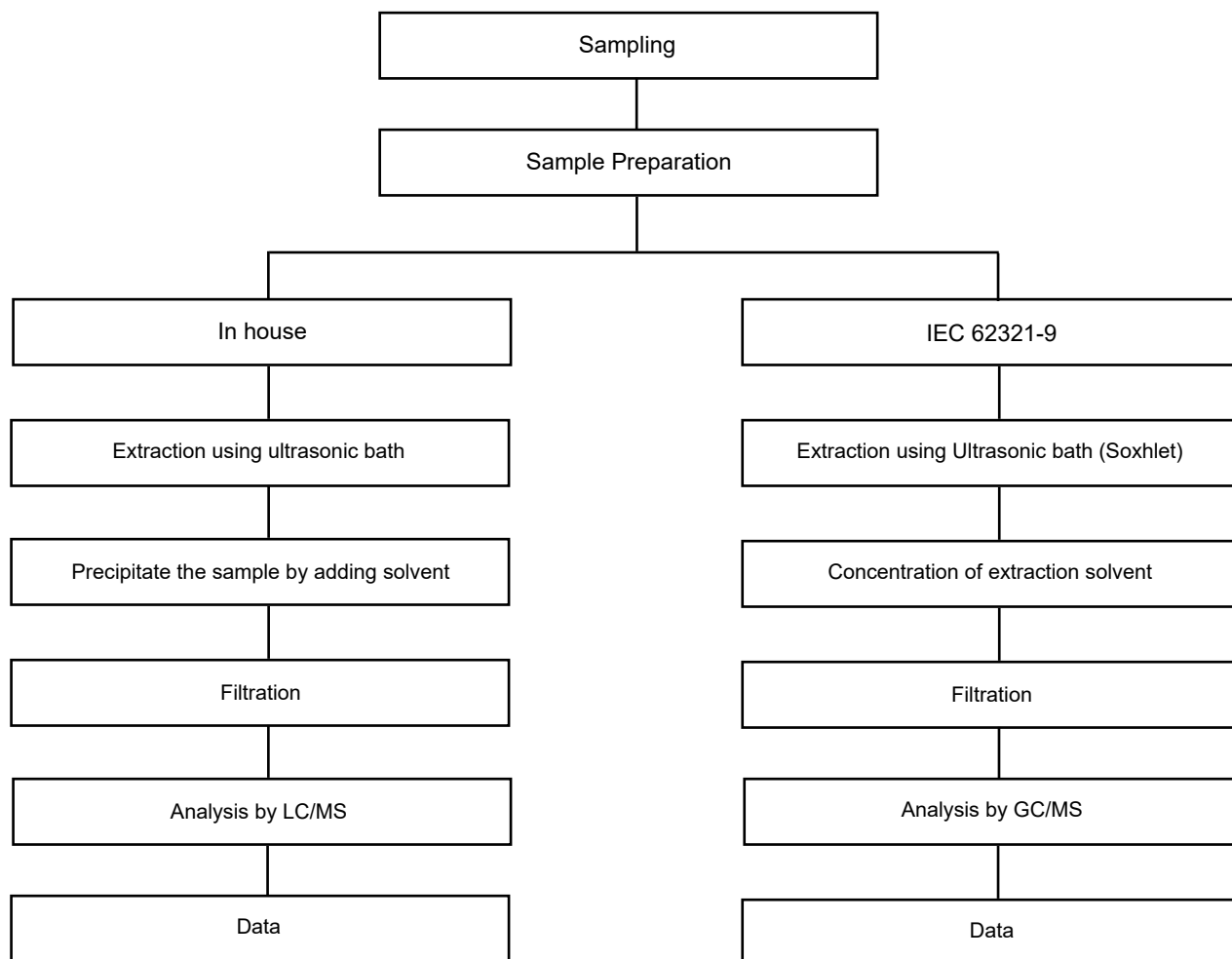
Flow Chart for Heavy metal

Flow Chart for PFAS (All material)



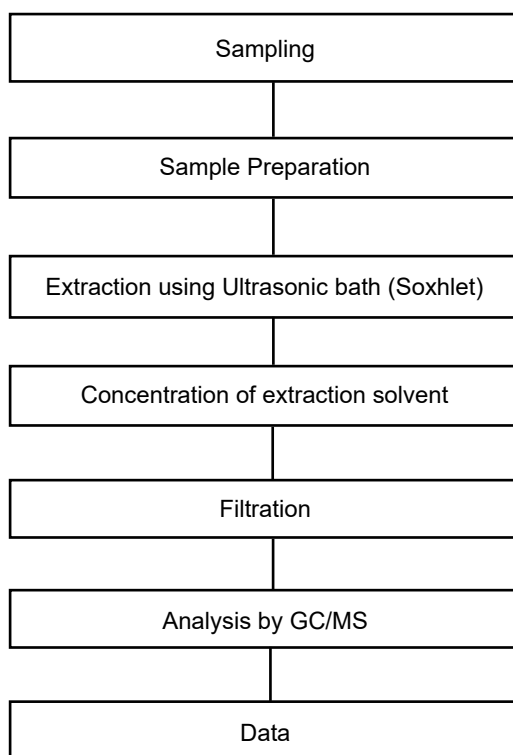
